

## **EXTRACT OF THE INSURANCE CONDITIONS**

### **CONTRACT N° 748587**

*A copy of the General Conditions on this contract is available to the insurer.*

Your camping has subscribed to the FINISTERE ASSURANCE the contract n° 748587 to cover you on the consequences of a cancellation order an interruption of your stay.

#### **CANCELLATION OF THE STAY – BEFORE YOUR DEPARTURE, in case of:**

- Decease, serious accident, serious illness, including the worsening of the illness pre-existing of you or a family member, and a person who leaving usually with you or a person coming with you in holiday (written on the rental booking contract)
- Decease of the uncle, aunt, nephews and nieces of the assured party
- Serious material damages on your professional or private properties, 48h before your departure
- Getting a job after the date of your booking accommodation
- Convocation or event professional or administrative
- Economic dismissal of the assured or his spouse
- Professional mutation impose by the employer
- Cancellation or modification of the paid holidays impose by the employer
- Serious car damages of the assured in the 24h before the departure

You will be refund :

- of the paid account amount ( except the handling charge and insurance premium) in case of event happened between the booking date and the 30<sup>th</sup> day before the entrance in the accommodation
- Of the accommodation amount ( except the handling charge and insurance premium) in case of event less of 30 days before the entrance in the accommodation

*An excess of 30€ stay at your charge ( except specifical excess)*

#### **INTERRUPTION OF THE STAY, in case of:**

- Serious illness, serious corporal accident, the assured decease, his spouse, ancestry or descendant to the 2<sup>nd</sup> degrees, fathers-in-law, mothers-in-law, brothers, sisters, brothers-in-law, sisters-in-law, and all the people who leaves with the assured
- A theft, a serious fire damages, explosion, flood damages, or cause the nature of the professional places or private of the assured and to imperative imply his presence to take some necessary preserve measure.

*You will be refund of the amount about the part not do of the stay and already invoice by the camping.*

#### **GENERAL EXPULSIONS**

*All the events no indicate before are except.*

Apart the generals expulsion, aren't guaranty the consecutive cancellations to:

- Illness or accident who do the object of a beginning, a relapse, aggravation, or a hospitalisation in the months before the stay's entering.
- Esthetic treatment, treatment, voluntary termination of pregnancy, in vitro fertilization, artificial insemination, pregnancy
- Psychic illness or mental or depressive
- Epidemics

#### **OBLIGATION IN CASE OF DISASTER**

- To tell the camping direction next you do your booking when happen the disaster. ( If you cancel too late, we can't take in charge the cancellation costs payable at the date when it's happen) ;
- Address all the necessary documents to do the file, to prove the well-grounded and the amount of the claim.
  - for a cancellation, the medical certificate who prove the nature, the origin and gravity of the accident or the illness .
  - a decease bulletin
  - in all cases, all supporting documents on the event
